View the popularity of your Offshore Library listings

From your profile page, you have the opportunity to view the site statistics that apply to your account.

You will be able to see how many times your pages have been viewed and how many times site members have downloaded documents (presentations) and how many requested further information in relation to your company, products and services.





Getting Started

Listing your Company & Fund Data

The first thing you need to do is to register as an individual site member by visiting:
www.offshore-library.com/members/user_register_account.php

After you have registered, decide on which membership option best suits your business, and complete the business registration form.

You will receive a confirmation email, invoice and payment instructions.

Once your payment has been confirmed, your account will be activated and you'll then be able to login to your account profile page and begin adding your corporate profile and fund data within the relevant categories.

Once complete, you can start to post news, product launches and service updates.
